- PRACTICE ROUNDS:** Can be arranged by contacting the golf shop at Hillcrest Country Club (402) 489-8181. Fee for single practice round is \$39 + tax (additional fee of \$17 for cart). Please note, the course is closed on Mondays.
- FOOD & BEVERAGE:** The men's locker room will be open for food & beverage service. Cash, credit cards and club reciprocals are accepted for purchases.
- PRACTICE FACILITIES:** Range balls are complimentary and will be available on the practice range.
- REGISTRATION:** Registration will be located just outside the golf shop beginning at 7 a.m. You are expected to check in prior to your starting time.
- LOCKER ROOM:** You may use the locker room but individual lockers are not available.
- RANGEFINDERS:** The use of Distance Measuring Devices is permitted.
- GOLF BALLS:** Only brands of golf balls on the most current USGA List of Conforming Golf Balls may be used. The "One-Ball Rule" is in effect.
- GROOVE STANDARDS:** It is a requirement that a player's clubs conform to the groove specifications provided in the Rules of Golf. See separate memo included in the attached rules packet for specific details.
- TRANSPORTATION:** Automotive transportation is permissible for players only. Caddies must walk at all times during the stipulated round.

- CADDIES:** A player may provide his own caddie. Pull/push carts are permitted.
- PACE OF PLAY:** Qualifying participants must play without undue delay and in accordance with guidelines established by the Committee that are included in the attached packet.
- EVACUATION PLAN:** In the event of a discontinuance of play during the qualifier, players must adhere to the evacuation plan distributed at the starting tee.
- SPECTATORS:** Spectators are allowed and encouraged. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- DRESS CODE:** Players and caddies must be neat in appearance with respect to clothing and personal grooming. The Committee in charge will decide whether this requirement has been met, and has authority to withdraw the entry of a player who does not comply.
- FOOTWEAR:** Hillcrest prohibits metal spikes. Penalty for breach is disqualification.
- QUALIFYING PLACES:** There are 16 entrants competing for 1 qualifier place.
- PLAY-OFF:** In the event of a tie for the qualifying place, there will be a hole-by-hole play-off to determine the place winner and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
- LOWEST SCORE:** Silver medal, if a tie, duplicate medals will be awarded.
- STARTING TIMES:** See attached report for groupings and starting times.
