- PRACTICE ROUNDS:** Can be arranged for a fee of \$65 by contacting the golf shop at 402.571.7470.
- FOOD & BEVERAGE:** On the qualifying day the men's locker room will be available for beverage service. Course bars will be open for food and beverage purchases; the patio, sun room and main bar will also be available to participants and guests for the same purpose beginning at 11 a.m. Cash purchases or club reciprocals only for food and beverage. Note: There are no ATM machines on site.
- PRACTICE FACILITIES:** Practice areas will open at 6:30 a.m. Range balls are complimentary.
- REGISTRATION:** Registration will be located on the driving range beginning at 6:30 a.m. Players are required to check in prior to their starting time.
- LOCKER ROOM:** You may use the locker room but individual lockers are not available.
- CADDIES:** Participants may carry their own bag or bring their own caddie.
- TRANSPORTATION:** Transportation is prohibited. Players and caddies shall walk at all times during the stipulated round unless otherwise specified by the Committee. Pull/push carts are permitted.

- RANGEFINDERS:** The use of Distance Measuring Devices is prohibited.
- GOLF BALLS:** Only brands of golf balls on the most current USGA List of Conforming Golf Balls may be used. The “One-Ball Rule” is in effect.
- GROOVE STANDARDS:** It is a requirement that a player’s clubs conform to the groove specifications provided in the Rules of Golf. See separate memo attached to this packet for specific details.
- PACE OF PLAY:** Qualifying participants must play without undue delay and in accordance with guidelines included in the accompanying rules packet.
- EVACUATION PLAN:** In the event of a discontinuance of play during the qualifier, players must adhere to the evacuation plan included in this packet.
- SPECTATORS:** Spectators are allowed and encouraged. Per USGA guidelines, the use of golf carts for spectators is prohibited.
- DRESS CODE:** Players and caddies must be neat in appearance with respect to clothing and personal grooming. The Committee in charge will decide whether this requirement has been met, and has authority to withdraw the entry of a player who does not comply.
- FOOTWEAR:** The Country Club prohibits traditional metal spikes, therefore, these type of shoes are not permitted. Penalty for breach of this rule is disqualification.
- QUALIFIER PLACES:** The field of **69** contestants will compete for **4** sectional qualifying places and **2** alternate positions.
- PLAY-OFF:** In the event of a tie for the last qualifying place, there will be a hole-by-hole play-off to determine place winners and alternates. Any announcements regarding the play-off will be made at the public scoreboard upon completion of the qualifying round.
- LOWEST SCORE:** Silver medal, if a tie, duplicate medals will be awarded.
- STARTING TIMES:** See attached report for groups and start times.
