NOTICE TO PLAYERS

(This notice supplements the Local Rules and Terms of the Competition for NebGolf Competitions)

1. **Ground Under Repair**, includes but is not limited to:
 - a. Prepared Flower and Plant Beds including even though not so defined by white lines.
 - b. Turf Nursery left of Hole #3 from which play is prohibited. This area is not defined but constitutes all turf mowed to putting green height or less.
2. **Immovable Obstructions:**
 - a. Include but are not limited to:
 - i. Artificially Surfaced Roads and Paths include those surfaced with crushed brick, gravel or asphalt.
 - ii. Arboretum signs.
 - b. Prepared flower and plant beds adjacent to an Immovable Obstruction are deemed to have the same status.
 - c. Hole #12 – white stakes along the right side are deemed to be immovable obstructions during play of #12.
 - d. Hole #18 – white stakes along the right side are deemed to be immovable obstructions during play of #18.
3. **Out of Bounds:**
 - a. The White Stakes along the right of hole #1 define out of bounds for that hole only.
 - b. The White Stakes along the right of hole #4 define out of bounds for that hole only.
 - c. Out of Bounds is defined by the perimeter fence in addition to white stakes and white lines.
 - d. Concrete Bases of Boundary Fence Posts – are part of the fence and thus not an obstruction.
 - e. The Chain Link Fence along the right of hole #7 and hole #11 is out of bounds in addition to white stakes present on those holes.
4. **Penalty Areas:**
 - a. Red Penalty Area on hole #18: A portion of the penalty area is defined by the penalty area side of the cart path.
5. **Power Lines:** Model Local Rule E-11 is in effect.
 - a. Hole #8—If it is know or virtually certain that a player's ball strikes a power line, the stroke does not count. The player must play a ball without penalty from where the previous stroke was made (see Rule 14.6 for what to do).
6. **Temporary Immovable Obstructions (TIOs):** Model Local Rule F-23 is in effect. TIOs include but are not limited to: championship tents.
7. **Scoring Area:** A scorecard is deemed to be returned when the player has left the scoring tent defined by blue dots.
8. **Teeing Area:** Red NebGolf tee markers define the teeing area.
9. **Pace of Play Review Committee:** Justin Ahrens, Craig Ames and Ben Vigil.
10. **Final Decisions on Disputed Points** will be made by Justin Ahrens, Craig Ames and Ben Vigil.
